

## 13th VILNIUS SYMPOSIUM ON LATE SOVIET AND POSTSOVIET ISSUES

Inclusive and/or Alienating Political Power. Tsarist and Soviet Rule on the Western Peripheries

5-6 December, 2024

Venue: Lithuanian Institute of History (17 Tilto Street, Vilnius, Lithuania)

The tsarist era of the long 19th century was replaced by Soviet rule in the short 20th century. The two empires differed significantly in their nature, as well as in their political and economic systems and their international position. Although in the Western region, the two decades of freedom and statehood represented a significant break between the two imperial governments, moments of historical memory and even institutional behaviour created links between them. Despite the efforts of communist ideology and nationality policy to distance itself from the tsarist past, societies were imbued with images of the representatives of the centre as imperialists, even as governors-generals as in case of communist party second secretaries. One might even ask how sincere, consistent and successful the Soviet regime and its representatives were in overcoming the imperial legacy of tsarism. To what extent did the newly created Soviet institutions take over and preserve memory and certain patterns of behaviour?

During the symposium we will try to answer these questions by analysing the institutional set-up of Tsarist Russia and the USSR, the centre-periphery relations, the political and administrative behaviour of the representatives of the centre, and the relations with the local societies. Whether there was a national hierarchy, how the governments were interested in and studied the local people, how national discrimination manifested itself or could be observed, how local people were (or were not) involved in governance. The symposium will discuss the nature of governance in the Russian Empire and the Soviet ethno-federation, their similarities and differences. The focus will be on the interaction of the institutes of the centre with local ethnic and confessional communities and political and cultural elites.
